Terms & Conditions

1. INTRODUCTION

- 1.1 This competition is operated by Ticketmaster UK Limited company number 02662632, whose registered office is at 4 Pentonville Road, London N1 9HF ("**We**", "**Our**", "**Us**").
- 1.2 The following terms and conditions ("**Terms and Conditions**") apply to a competition to win a 'VIP Experience for a performance of Muse, as detailed under the Prize heading in clause 2.1 ("**Competition**"). The Competition is run through Our YouTube page (<u>http://www.youtube.com/user/UKTicketmaster</u>).
- 1.3 Please read these Terms and Conditions carefully. These Terms and Conditions set out who can enter the Competition, how the Competition will be run and the circumstances in which We may withhold all or part of the Prize and/or disqualify you. By submitting an entry for the Competition, you agree to be bound by these Terms and conditions and agree that you grant Us the right to use your entry as set out below.

- 1.6 We reserve the right to disqualify your entry if We have reasonable grounds to believe that you have breached any of these Terms and Conditions.
- 1.7 We reserve the right to suspend, cancel or modify the Competition at any time (and for any reason) without notice.

2. DEFINITIONS

2.1 In these terms and conditions (except where a different interpretation is necessary in the context) the words and expressions set out below shall have the following meanings:

3. ELIGIBILITY

The video you submit must: (i) be in .flv, .wmv, .mov, .mpeg or .avi. format; (ii) be no longer than four (4) minutes, the frame size; (iii) have a quality of 480x360 or higher; and (iv) be no larger 2GB.
- 4.2 Entries to the Competition must be received by us between the Start Date and the End Date (inclusive). Any entries received by Us outside this period shall not be considered regardless of the reason.
- 4.3 We shall be entitled to disqualify any entry which We believe: (i) include false or misleading information; or (ii) otherwise breaches these Terms and Conditions.

5. YOUR ENTRY

- 5.1 By entering the Competition you agree that:
 - (a) We will be the owner of the intellectual property rights in your entry and to this end you will assign to Us, with full title guarantee, all intellectual property rights in your entry (other than those already owned by any third party);
 - (b) you will irrevocably waive all moral rights in your entry;

6 JUDGING

- 6.1 We will review all entries received by Us which comply with these Terms and Conditions.
- 6.2 We will select, in Our opinion, the best four (4) entries. The entrants who submitted those entries will be the winners of the Competition.
- 6.3 The winner(s) of the Competition will be notified by email or telephone within five (5) days of the Notification Date. It is the responsibility of entrants to notify Us of any change of contact details. Proof of identity may be required.
- 6.4 We will have the right to disclose the name of the winner(s) and their city/town of residence. By entering the Competition, you expressly agree to permit such disclosure if you are the winner.

- 7.3 Only one winner (and their companion) can attend each performance of the Muse. If you are the winner and cannot attend on the night allocated to you, you forfeit all rights to the Prize and an alternate winner may be selected by Us.
- 7.4 We reserve the right to provide a substitute prize of similar value should the need arise.
- 7.5 An unclaimed Prize may not be awarded. The Prize is strictly non-transferable and no cash alternative is offered.
- 7.6 The winner and their companion will be solely responsible for their own accommodation and travel and all other expenses in connection with the Competition and the Prize. We assume no responsibility and are not liable for any costs, charges or expenses which any winner may be required to pay at any time in connection with the Competition or the Prize.
