Terms and Conditions for Ticket Purchasing by Deposit Ticket Scheme

- 1. Early Bird Weekend tickets for Standon Calling 2017 ("Tickets") can be bought using a Deposit Ticket Scheme ("DTS"). This allows Tickets to be paid for over two (2) payments (each an "Instalment"). The DTS is available to any customer buying a Ticket between 1st August 2016 at 9am and 17th June 2017 at 23:59 pm (the "Eligibility Period"), subject to Ticket availability. The Eligibility Period may be shortened or extended by us at our discretion. The first Instalment will be charged immediately and to be eligible for the DTS the payment must be paid within the Eligibility Period.
- 2. The full price of your purchase of the Ticket, being £117.70 (one hundred and seventeen pounds and seventy pence per Ticket) include a £10.70 per Ticket booking fee.

- 4. The first Instalment will be charged to your credit or debit card immediately. The final Instalment will be automatically charged to your credit or debit card on or around the above due date (4th July 2017), without further recourse to you, unless you contact Ticketmaster on 0333 321 9999 to pay the final Instalment before the due date. If your card is declined, you will be contacted for an alternative card. If we are not provided with an alternative card within 5 days of the due date, your Ticket will be void, but you will not receive a refund for the first Instalment.
- 5. Tickets will be dispatched to you via Ticketfast email at no extra charge after payment of the final Instalment has been successfully taken.
- 6. The transaction will be completed only once your payment of both Instalments has been processed, with the total of £117.70 paid in full.
- 7. If you do not pay the final Instalment in full in accordance with paragraph 4 above, you will lose (i) the first Instalment; and (ii) the Ticket(s) to which you were entitled under the DTS.
- 8. The DTS requires that, at the time the first Instalment is made, you make a full commitment to purchase a Ticket and pay the full Ticket price.
- 9. It is recommended that you ensure that adequate funds are in place to process the payment of both Instalments on the dates set out in paragraph 2 above and that your credit or debit card does not expire before the final Instalment can be charged.
- 10. The first Instalment is non-refundable save where Standon Calling 2017 is cancelled. In all other circumstances, no claim can be made to recover this money in any way whatsoever.
