

## Terms and Condition for ticket purchase by Ticket Instalment Scheme

1. 'Weekend' tickets for Reading or Leeds Festival 2017 ("**Tickets**") can be bought using a Ticket Instalment Scheme ("**TIS**") that allows Tickets to be paid for over two (2) payments (each an "Instalment"). The TIS is available to any customer buying a Ticket between 11am 5<sup>th</sup> April 2017 and Midnight 30th April 2017 (the "Eligibility Period"), subject to Ticket availability. The Eligibility Period may be shortened or extended by us at our discretion. Subject to paragraph 10 below, both Instalments (including booking fee) are non-refundable and must be paid within the Eligibility Period.
2. The full price of your purchase of each Ticket will be charged as follows:  
 "Weekend Ticket" £205.00 (two hundred and five pounds sterling) (face value of £205.00 plus a £8 per Ticket booking fee) plus a per transaction delivery fee of £6.50 (six pounds and fifty pence sterling), will be charged as follows:

First Payment (non – refundable)	£108.00 per ticket (including a £8 booking fee per Ticket)	Immediately
Second Final Payment (non – refundable)	£105.00 per ticket + £6.50 Secure post fee per transaction	Total amount due by 1 <sup>st</sup> June 2017

3. Subject to paragraph 10 below, both Instalments are non-refundable and no claim can be made to recover this money in any way whatsoever. The first Instalment includes a per Ticket booking fee and as set out above which, subject to paragraph 10 below, is also non-refundable.
4. The first Instalment (including booking fee) will be charged to your credit or debit card immediately upon your election to purchase the Ticket during the Eligibility Period. The Second and final instalment will be automatically charged to your credit or debit card on or around the above due date (1<sup>st</sup> June 2017) without further notice to you, unless you contact Ticketmaster on 0333 321 9999 to pay the second Instalment before the due date. If your card is declined, you will be contacted for an alternative card. Any alternative card must belong to, and be in the name of, the original purchaser. If we are not provided with an alternative card within 5 days of the applicable due date for which payment is due, your purchase of the Ticket will be cancelled and your Ticket void, and you will not receive the Ticket or a refund for the first Instalment (including booking fee).
5. Tickets will be dispatched to you via Secure delivery closer to the event date and

once all payments have been successful and booking finalised.

6. The transaction will be completed only once your payment of all Instalments has been processed, with the totals as set out in Paragraph 2, paid in full.
7. **If you do not pay the final Instalment in full in accordance with paragraph 4 above, you will lose (i) the first Instalment (including booking fee); and (ii) the Ticket(s) to which you were entitled under the TIS.**
8. The TIS requires that, at the time the first Instalment is made, you make a full commitment to purchase a Ticket and pay the full Ticket price plus booking fee.
9. It is recommended that you ensure that adequate funds are in place to process the payment of all four Instalments on the dates set out in paragraph 1 above and that your credit or debit card does not expire before the final Instalment can be charged.
10. Both Instalments (including booking fee) are non-refundable save where Reading or Leeds Festival 2017 is cancelled. In all other circumstances, no claim can be made to recover this money in any way whatsoever.
