## Terms and Conditions for Ticket Purchasing by Deposit Ticket Scheme

- 1. Tier One Weekend tickets for Valley Fest 2017 ("Tickets") can be bought using a Deposit Ticket Scheme ("DTS"). This allows Tickets to be paid for over 4 (four) payments (each an "Instalment"). The DTS is available to any customer buying a Ticket between 16<sup>th</sup> January at 10am and 01<sup>st</sup> April 2017 at 23:59 pm (the "Eligibility Period"), subject to Ticket availability. The Eligibility Period may be shortened or extended by us at our discretion. The first Instalment will be charged immediately and to be eligible for the DTS the payment must be paid within the Eligibility Period.
- 2. The total price of your Ticket will be £115.50 (one hundred and fifteen pounds and fifty pence) per Ticket, which will include a £5.50 (five pounds and fifty pence) booking fee per ticket. This will be spread across 4 instalments, as outlined below.

Fourth	£27.50 per Ticket plus £2.95 post out charge.	3rd July 2017

- 3. Subject to paragraph 10 below, the first Instalment is non-refundable and no claim can be made to recover this money in any way whatsoever. The first Instalment includes a per Ticket booking fee of £5.50, which, subject to paragraph 10 below, is also non-refundable.
- 4. The first Instalment will be charged to your credit or debit card immediately. All subsequent payments will be automatically charged to your credit or debit card on or around the above due dates as outlined in paragraph 2a, without further recourse to you unless you contact Ticketmaster on 0333 321 9999 to pay the final Instalment before the due date. If your card is declined, you will be contacted for an alternative card. If we are not provided with an alternative card within 5 days of the due date, your Ticket will be void, but you will not receive a refund for the first Instalment.
- 5. Tickets will be dispatched to you via standard post, £2.95 charged after the final Instalment has been successfully taken.
- 6. The transaction will be completed only once your payment of all 4 (four) Instalments have been processed, with the total of £115.50 plus £2.95 post out charge paid in full.

- 7. If you do not pay the final Instalment in full in accordance with paragraph 4 above, you will lose (i) the first Instalment; and (ii) the Ticket(s) to which you were entitled under the DTS.
- 8. The DTS requires that, at the time the first Instalment is made, you make a full commitment to purchase a Ticket and pay the full Ticket price.
- 9. It is recommended that you ensure that adequate funds are in place to process the payment of both Instalments on the dates set out in paragraph 2 above and that your credit or debit card does not expire before the final Instalment can be charged.
- 10. The first Instalment is non-refundable save where Valley Fest 2017 is cancelled. In all other circumstances, no claim can be made to recover this money in any way whatsoever.
