Terms and Conditions for Ticket Purchasing by Deposit Ticket Scheme

- 1. "Three Day Weekend" tickets for TRNSMT Festival 2020 can be bought using a Deposit Ticket Scheme (DTS) that allows eligible customers to pay for tickets over 3 payments (each an 'Instalment'). The DTS is available to any customer buying a ticket ONLINE between 17th July and 31st July 2019 (the "Eligibility Period"), subject to ticket availability. The first Instalment must be paid within the Eligibility Period.
- 2. The full price of your purchase of the ticket will be charged as follows:

- 3. Subject to paragraph 10 below, the first Instalment is non-refundable, and no claim can be made to recover this money in any way whatsoever. The first Instalment includes a booking fee of £11.60 per ticket and Facility Charge of £3, which, subject to paragraph 10 below, is also non-refundable.
- 4. The first Instalment will be charged to your credit or debit card immediately upon your election to purchase the ticket during the Eligibility Period. The second and final Instalments will be automatically charged to your credit or debit card on or around the due dates, as set out in the table in paragraph 2 above without further recourse to you. If your card is declined, you will be contacted for an alternative card. Any alternative card must belong to, and be in the name of, the original purchaser. If we are not provided with an alternative card within 5 days of the relevant due date, your ticket will be void but you will not receive a refund of the first Instalment (including booking fee).
- 5. A per transaction cost of handling and delivery of the ticket will be added to, and paid for at the time of, the final Instalment.
- 6. The transaction will be completed only once your payment of all three Instalments has been processed.
- 7. If you do not pay any of the Instalments in full by the dates set out in paragraph 2 above and we are not provided with an alternative credit or debit card within 5 days of the relevant due date, you will lose (i) the first Instalment (including booking fee) and (ii) the ticket(s) to which you were entitled under the DTS.
- 8. The DTS requires that, at the time when the first Instalment is paid, you make a full commitment to purchase a ticket and pay the full ticket price plus booking fee and delivery cost.
- 9. It is recommended that you ensure that adequate funds are in place to process the payment of all three Instalments on the dates set out in paragraph 2 above and that your credit or debit card does not expire before the final Instalment can be charged.
- 10. The first Instalment (including booking fee & Facility Charge) is non-refundable save where TRNSMT 2020 is cancelled. In all other circumstances, no claim can be made to recover this money in any way whatsoever.
- 11. Tickets cannot be refunded or exchanged after your transaction has been completed save as provided in Ticketmaster's Purchase Policy referred to in paragraph 12 below or pursuant to paragraph 10 above.
